**Article-5: Aims and objects of the Trust:**

1. To provide and promote, general, secular, scientific, technical, medical, vocational, professional and other education to meet out social cause of the people in general, minorities in particular.

**Article -8: Power of Managing trustee or Board of Trustees:**

I. The Management, Administration and Superintendence of the trust in general shall be with the Chief Trustee, in case of Board of Trustees, shall be with the Board.

II. The Powers of the Chief Trustee:

The Chief trustee is invested with the following powers

- a. To borrow the funds for the trust.
- b. To acquire moveable and immovable properties in any form, for the objects of the trust in the name of trust, hold and deal with such properties, from any individuals, trust, society, Govt. and Semi Govt. and other organizations etc.
- c. To appoint personals/employees to administrator the objectives of the trust, and shall frame code of conduct for administration of trust, and to alter or amend or rescinde the code of conduct from time to time.
- d. Shall not set up title and interest adverse to the Aims and objects of the trust.

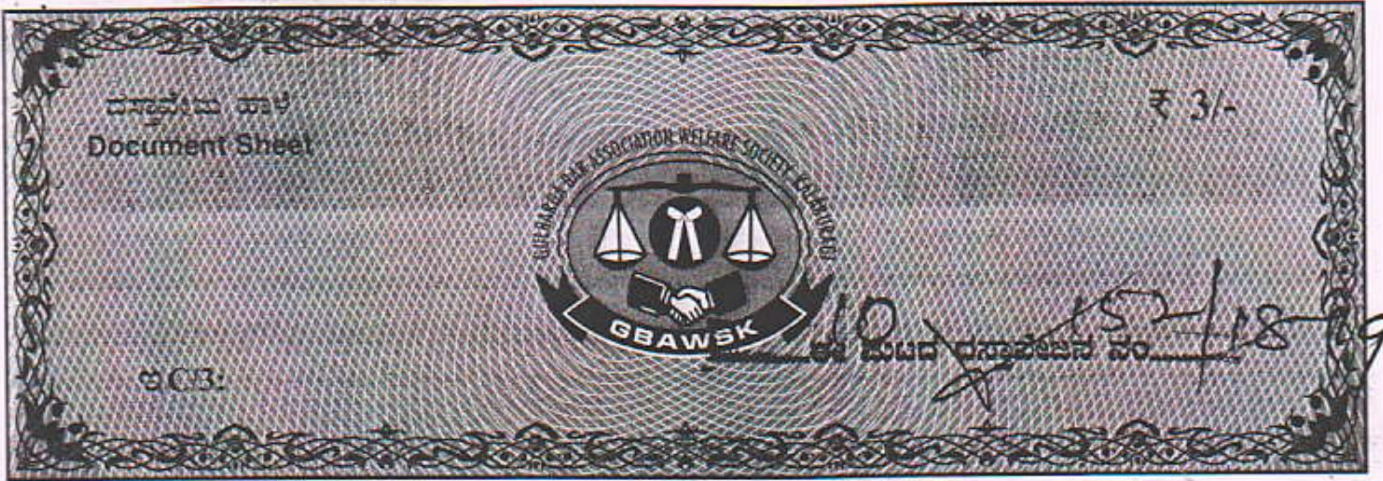

- e. Has the power to sue or to be sued to appear and defend the litigations before the Authorities, courts, execute the documents, enter into contract which are not determinatal to the Aims and objects of the trust, relating to movable and immovable properties.
- f. Has the power to accept Donations, secure funds, contributions or otherwise for the trust.
- g. Has the power to draw the reasonable remuneration or allowance towards his service in administration of the trust, the same shall be met from the trust fund.
- h. Has power to amend, alter and resend any of the clause of this deed of trust in a manner not inconsistence or repugnant to the Aims and objects of the trust.
- i. Has power to reimburse himself all expenses, charges incurred in or for the executions of the objects, out of the trust funds.

- j. In case of any ambiguity in the interpretation of terms of this instrument, such interpretations shall not conflict with the Aims and objects of the trust.

**Article-9: Trust fund:**

The Trust fund shall comprise of the nucleus of the amount received from the Donations, Gifts, Aids from the Govt., Semi Govt. organizations, Charitable social organization, trust, societies, loans, borrowings, all other sums realized or received from the Indians, Non Indians to augment the trust fund.

**Article-10 : Investment of trust funds:**

Funds of the trust may be profitably invested in Nationalized Banks, Govt. Bonds, Securities, credit, cooperative banks and in acquiring movable and immovable properties for the trust to achieve the Aims and objects of the trust.

**Article-11: Accounts of the trust:**

The Accounts of the trust shall be kept at the office of the trust, shall be Audited periodically by the registered Chattered Accountant

**Article-12: Operation of the Bank Accounts:**

All banking transactions shall be operated by the Chief Trustee.

**Article -13 : Meetings**

In case of formation of Board of Trustees meetings shall be as often as may be necessary to transact the affairs of the trust also take decision by circulation of agenda, if necessary.

**Article-14 : Proceedings of the trust :**

All proceedings shall be taken and conduct in the name of trust, shall maintain the records, shall be in English language.

**Article -15: Beneficiaries :**

The beneficiaries shall be particularly from minorities, in general from other communities, the form of benefit shall be imparting education, educational benefits, charities and social welfare.

**Article-16 : Amalgamation :**

The trust can amalgamate or take over the other educational institutions, from other trust or societies of similar aims and objects in case of their given up or dissolution of such trust or societies followed by their resolutions to that effect.

**Article -17 : Legal Jurisdiction :**

All matters, disputes, claims and litigation shall be under the trust Act.

**Article-18 : Revocation or dissolution of trust:**

In the event of revocation or dissolution of the trust, the assets and liabilities on the date of such even shall under no circumstances shall be the assets and liabilities of the Chief trustee or member trustees in case of appointment of other trustees, shall be determine by the jurisdictional principal civil judge, on such determination shall be transfer and vest with another trust whose aims and objects are similar of this trust and which enjoys recognitions under Section -80G of the Income Tax Act, 1961 as amended from time to time.
